AS WITH OTHER ORGANIZATIONS, COVID-19 HAD A SIGNIFICANT IMPACT ON OUR PROGRAMING. IN MARCH OF 2020, WE HAD 22 RESIDENTS OF WHOM 19 WERE EMPLOYED. THE STATE OF ARIZONA IMPLEMENTED STAY AT HOME ORDERS MID-MARCH. AS A RESULT, 3 RESIDENTS TERMINATED THEIR RESIDENCY WITH TREASURE HOUSE TO BE CLOSER TO FAMILY. 2 OF THESE RESIDENTS WERE FROM OUT OF STATE. ALL BUT 3 RESIDENTS LOST THEIR JOBS AND OUR COMMUNITY INTEGRATION PROGRAMS AND SERVICES WERE FROZEN. OUR TEAM QUICKLY IMPLEMENTED INCREASED SANITATION EFFORTS, 100% WORK MASKS, ON-LINE GROCERY SHOPPING, IN-HOUSE FITNESS CLASSES, INCREASED IN-HOUSE ACTIVITIES ETC. THOSE RESIDENTS WHO WERE ENROLLED IN COLLEGE SHIFTED TO ONLINE COURSE WORK WITH THE ASSISTANCE OF THE LIFE COACHING STAFF.

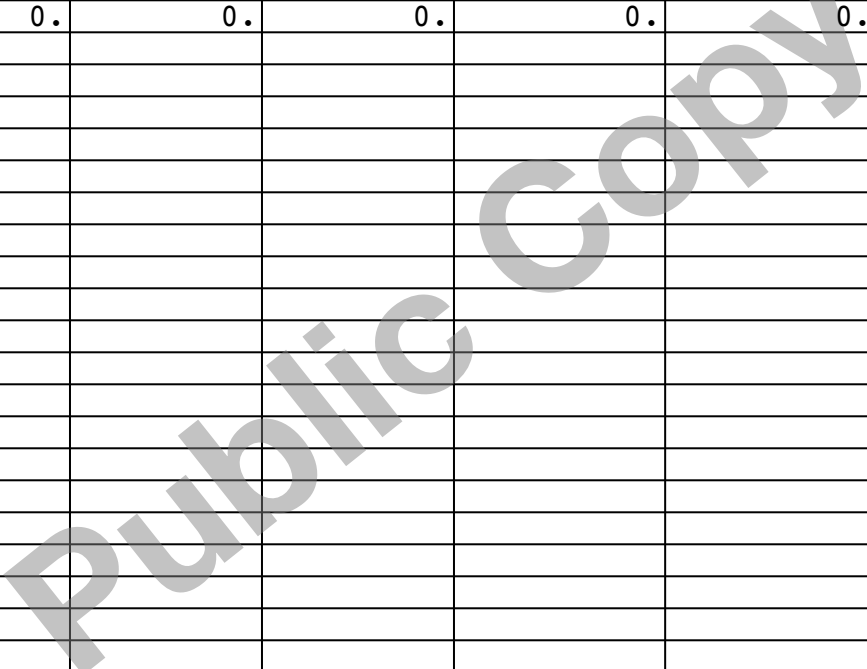
